To serve you better a final guest count is required at least two days prior to the event.

Deposit; A minimum of \$100.00 deposit is required on all parties. Your deposit will be fully refunded if 95% or more of your confirmed guests attend the party and order an entree. Your deposit is not a guarantee for a private room, unless otherwise specified in this contract. Any alterations or cancellations must be done at least 48 hours prior to the function in writing, or 100% of customer deposit will be forfeited. All guests attending the party must order food from our menu.

No outside food or liquor is allowed. Prices are subject to change.

For parties that require additional time for meetings before or after the food has been served, there will be an additional charge of \$150.00 per hr for room and \$35.00 per hr per server. _____ (Customers Initial)

To reserve our space for appetizers and drinks there is a \$250 room rental fee. This fee will include 2.5 hours. In addition you will be required to have a minimum fee of \$15 per person to include beverage and appetizers. A standard gratuity of 20% will be added to your party as well. _____ (Customer Initial)

Gratuity: An 20% gratuity will be added to all parties of 8 or more. On all parties of 10 or more requesting to pay by separate checks, please allow us an additional time to process your checks. *No separate checks will be allowed on parties of 30 or more.*

Important: Customers and Summit Hickory Pit BBQ agree that this contract is the complete agreement between the parties, and that everything which the customer expects the Summit Hickory Pit BBQ to perform is written here. Customers and Summit Hickory Pit BBQ further agree that this contract can be modified in writing only, and no oral modification should be valid.
